The builder of this experimental automobile is NOT a professional mechanic, and has no industry licenses or certifications. The registered owner is free to make any modifications or changes to the design as he/she sees fit. The automobile is an example of the owner/builder's creative ability. Upon sale, the new registered owner of an experimental-amateur built automobile becomes its manufacturer. The new owner becomes responsible for its structural function/concept along with its maintenance and insuring the said Automobile in safe condition. The new owner is responsible for the performance and fit or purpose of every part/piece on the automobile. The said Automobile as designed contains none of the modern safety features, and therefore is not designed for anything other than normal street driving and posted speed limits. Racing or track driving is not recommended and owner does so at their own risk and assumes all liability.

No warranty of any kind, either expressed or implied, is made to the Purchaser or anyone else as to the merchantability or road worthiness of this experimental automobile. The experimental automobile is sold on an "AS IS" with all faults basis, as the Seller is an amateur builder of this experimental automobile and, by virtue of being experimental, this automobile does not comply with the Federal Safety Regulations for "Manufactured Automobiles".
